

DUGOUT/OM TERMS & CONDITIONS

1. INTRODUCTION

- 1.1 By entering the promotion, all participants will be deemed to have accepted these terms and conditions in full. All entry instructions form part of these terms and conditions.
- 1.2 The promotion is open to anyone who fulfils all of the following criteria:
- (a) is aged 18 or over at the date on which they enter the promotion;
 - (b) is resident in a country where it is lawful: (i) for the entrant to enter the promotion, and (ii) for the promoter to promote the competition and award a prize to the entrant;
 - (c) is not an employee or immediately related to an employee of the promoter, its group companies, agents or anyone professionally connected with this promotion;
 - (d) is not subject to a football banning order anywhere in the world.
- 1.3 Entry to the promotion opens at 09:00 GMT on 15/06/20 and closes at 17:00 GMT on 30/06/20. No entries received after the closing time will be eligible to win a prize.
- 1.4 No purchase is necessary to enter the promotion. However, in order to enter the promotion, you must have an internet connection and a valid email account.

2. HOW TO ENTER THE PROMOTION

- 2.1 To enter the promotion, provide your first name, surname, date of birth, email address and country of origin. You will also be given the chance to opt-in for further email communications from Dugout and partner clubs – this is not necessary for eligible entry.
- 2.2 Only one entry is permitted per person. Multiple entries from the same person will be disqualified. The Promoter accepts no responsibility for entries that, for whatever reason, it does not receive before the promotion closing time.

- 3.2 Winners will be notified by email within 5 working days of the promotion closing date and will be asked to confirm their details for delivery of the prize.
- 3.3 The promoter will use reasonable endeavours to contact the winner. However, if the promoter is unable to contact a winner within 10 working days of the prize draw, the promoter reserves the right to award the prize to an alternative winner selected at random.

- 4.4 Should the prize be unavailable, the promoter reserves the right to substitute an alternative prize of equal or greater value. There is no cash alternative available. Prizes are non-

transferable and cannot be resold. Unless otherwise agreed in writing by the promoter, the prize will only be awarded to the winner.

- 4.5 Any images are an illustrative example and do not show the exact prize(s).
- 4.6 The promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition.

5. CONDITIONS

- 5.1 The promoter may publish each winner's name, photograph and country of residence (and county, if the winner is from the UK) on its website, Instagram, Facebook and/or Twitter account to publicise the prize-giving within a year of the closing date. Promoter may request that the winner participates in reasonable publicity in relation to the prize and, with the winner's consent, may film all or part of any experience included as part of a prize.

 - 5.3.2.3 posting (or who has previously posted) a post, entry or comment to their own and/or the promoter's social media pages that is, in the promoter's opinion, inappropriate, offensive, defamatory or upsetting to other participants, fans of the promoter or the promoter's commercial partners relevant to the promotion, or is directly aimed at the promoter, or contrary to applicable law, and, in the case of the promoter's social media pages, to remove any such entry or comment.
